Each day will consist of a two-hour training session followed by an hour of full-field games. The sessions are geared to give players advanced training in an environment that allows as much individualized teaching as possible. Instruction is aimed to players wishing to play soccer at the next level, so players are expected to set higher goals during the week of training. The camp is limited to 30 players.
